
**Shri P. Manna – In the Chair**

1. The meeting commenced to discuss the observations of the Finance Department, to whom the file containing the minutes of Technical Bid Evaluation by the Inter-Departmental Tender Committee was sent seeking their observations.
2. FD has categorically observed that it is the Tender Committee which is the absolute authority to decide on the technical eligibility of the consortium led by United Cycle Company and there is no need to refer to the Finance Department to adjudicate in the matter. FD has further observed that the findings prima facie indicate that the consortium led by United Cycle Company has not complied with the eligibility conditions, but the Tender Committee may take the final decision on whether its Technical bid is QUALIFIED or not.
3. In view of the above observations, upon considering the detailed evaluation of the Technical Bid of the consortium led by United Cycle Company carried out by the Tender Committee on 7<sup>th</sup> September, 2023 and on 11<sup>th</sup> September, 2023, the Tender Committee once again confirmed that the Technical Bid submitted by the consortium led by United Cycle Company is deemed to be not responsive in terms of the eligibility criteria provided under the Bidding Documents.
4. In view thereof, since Hero Cycles Ltd., Avon Cycles Ltd. and Hero Ecotech Ltd. have been already found to have qualified for opening of Financial Bids,

it was decided that the date and time for opening of Financial Bids of the above 3 bidders, be fixed on 9<sup>th</sup> October, 2023 at 3:00 P.M. The date and time of Financial Bid Opening was decided to be informed to the respective bidders, by way of email, so that they can depute their authorized representatives for the meeting.

5. In the meantime, the Corporation had also received a representation dated 3<sup>rd</sup> October, 2023, from United Cycle Company, whereby they have stated that since they are yet to establish manufacturing facility in the state, while, their sister concern, Unirox Bikes Private Limited have obtained land from WBIDC for establishing bicycles manufacturing facility in the state. Their letter is accompanied by letters from several local bicycle component manufacturers who agree to supply the components to united cycles, if an opportunity for supply of bicycles as a promotional order is given by the Corporation. Their letter also contains a letter of allotment of plot by WBIDC Ltd. for setting up of a bicycle manufacturing unit within the state.
6. Since, placing a promotional order to give fillip to the local manufacturers is beyond the scope of the present tender, it was decided that the Corporation would consider such proposal separately and take necessary steps in this regard.
7. The meeting ended with a vote of thanks to and from the Chair.
