1. Financial Bids in respect of both P-1 (1/2) AND p-2 (2/2) were decrypted one by one. Bidders present were given the opportunity of viewing the Financial Bid opening through projection in real time.
2. Financial Bids for Package-1 (1/2) was opened first in terms of ITB 35.1. Rates quoted by the bidders were as follows:-

3. Financial Bids for Package-2 (2/2) was opened thereafter. Rates quoted by the bidders were as follows:-

| Hero Cycles Ltd. | 6640.00 | 3320.00 | L1 |
| Avon Cycles Ltd. | 6640.00 | 3320.00 | L1 |
| Tube Investments of India Ltd. | 6654.00 | 3327.00 | L2 |

4. Tube Investments of India Ltd. was found to be the L1 bidder for Packages 1/2 and thus was declared as the Selected Bidder for the said packages.
5. In Package 2/2, as both Hero Cycles Ltd. and Avon Cycles Ltd. Ltd. are tie-bidders in terms of ITB 35.2, the Committee decided to split the package between the tie-bidders in terms of sub-clause (b) of ITB 35.2.
6. System generated BOQ chart (comparative statement of rates) in respect of both packages were signed by the bidders as well as by the members of the Tender Committee.
